Our bedroom is closest to the turbines I wake frequently in the night. Prior to the turbines I slept soundly. I woke up with headaches. When I work outside I have experienced intense ear pressure, and loss of balance.

The noise of the turbines, in certain conditions is unbearable & makes our workplace unbearable to be in. Some days it is like sounds of a jet taking off, but it does not go away. All these symptoms have only occurred since the turbines were turned on. It has put enormous pressure & stress on my home-working life to live and work around the Wauobra Wind Farm.
